MAURICE MOYER, first being duly sworn, upon oath, deposes and says: That he is a resident of the City of Prescott, Yavapai County, State of Arizona, and is 76 years of age.

Affiant is acquainted with Doris Farid, who, affiant is informed, is the complainant in that certain indictment returned against the said Constantino Vincent Riccardi in the United States District Court for the District of New Jersey, in the above entitled action, No. 4178-C.

Affiant states that during the early part of the month of July, 1945 affiant met said Doris Farid in New York City, New York and that he met the said Doris Farid again in the early part of August, 1945 in the City of Phoenix, Maricopa County, State of Arizona.

Affiant further states that during said occasions he had several conversations with said Doris Farid and during said conversations the said Doris Farid informed affiant that certain articles of personal property, which, affiant is informed is involved in said indictment, were sent by the said Doris Farid from Morristown, New Jersey to Phoenix, Arizona, and that said Doris

Farid informed affiant that she had given said articles of personal property to said Constantino Vincent Riccardi in appreciation of the assistance said Constantino Vincent Riccardi had given to her in connection with a tax proceeding which had been instituted by the Government of the United States against her, the said Doris Farid.

Affiant further states that during one of said conversations with said Doris Farid, she informed affiant that she was disposing of her home in Morristown, New Jersey, and that she would receive the same consideration upon the sale of her home as she would receive if it were sold without the articles of personal property which she was giving and sending to the said Constantino Vincent Riccardi.

Affiant states that he is a person 76 years of age, as aforesaid, and that he is now, and has been for sometime past, afflicted with a heart ailment and by reason thereof that he is not able to travel from the State of Arizona to the State of New Jersey for the purpose of appearing as a witness in said criminal proceedings.

Affiant states that he is now under the care of Dr. John F. McKenna, a physician who is engaged in his profession at Phoenix, Arizona, with offices at 39 West Adams Street, Phoenix, Arizona; that the said Dr. John F. McKenna has informed affiant that, in his professional opinion, affiant will be in such condition of health in approximately three months as will permit affiant to travel with safety and comfort from the State of Arizona to the State of New Jersey for the purpose of testifying on behalf of said Constantino Vincent Riccardi in said criminal action, and that affiant, if said criminal action is postponed approximately three months, will travel from the State of Arizona to the State of New Jersey for the purpose of testifying as a witness on behalf of said Constantino Vincent Riccardi.

Affiant states that if arrangements can be made therefor, he will voluntarily give his deposition on behalf of the said Constantino Vincent Riccardi and by said deposition will testify in full detail of the conversation which the said Doris Farid had with affiant, as aforesaid.
